### SECTION II: ELIGIBILITY CRITERIA

- 1. The Bidder firm should meet following eligibility criteria to qualify in the prequalification bid:
- (a) Capability, equipment and manufacturing facilities:
  - (i) The Bidder firm must have an annual capacity to manufacture and supply at least 36-MT of similar type of Cylinder Mould Multi-Tonal Water marked Paper.
  - (ii) The bidder also has to submit the following details along with the bid:
    - a) Name of the machine utilized to supply the quoted product.
    - b) The number of machine being utilized for the production and the capacity of each machine.
    - c) Total Annual capacity of the manufacturer.
    - d) Supply order in hand and proportionate capacity to supply quoted amount.

At the discretion of the purchaser, the capacity & capability assessment/verification of bidder / manufacturer firms shall be undertaken by Tender Evaluation Committee or through a third party Technical Consultancy/Inspection agencies to ensure that firms are identified and capable to develop the item as required.

- (b) Financial standing:
- (i) Average Annual Turnover of the Bidder firm should be more than Rs.75,14,720/- during last three years i.e. 2018-2019, 2019-2020 and 2020-2021.

Note: The 'Average Annual Turnover criteria' is exempted for Startups and Micro & Small Enterprises.

- (ii) The bidder should not have suffered any financial loss for more than one year during the last three years, ending on 31.03.2021.
- (iii) a) The net worth of the Bidder should not be negative on 31.03.2021 and also b) should not have eroded by more than 30% in the last three years, ending on 31.03.2021.
- (c) Name and complete address of the Cylinder Mould Manufacturer: .....
- (d) The bidder shall provide the details of the ownership of the company and details of owners/ directors along with complete addresses of the owners/ directors and their other activities. If the company is owned by another company similar details of the owner should be provided. The details are to be provided as per the format given Section VII (Format for submission of Key Personnel details). Also mention the name and other details such as address, age, share-holing percentage, passport details etc. of the ultimate beneficial ownership of the bidding firm.

If the bidder firm doesn't have the in house Cylinder Mould manufacturing facility, all the necessary details, as mentioned above, of the directors of Cylinder Mould manufacturer shall also be provided along with the offer for getting the Security Clearance of the same.

- 2. The capacity/ capability related data must be certified by the authorized signatory of the bidder firm.
- 3. The bidder has to submit a copy of audited financial documents (Balance sheets, Profit & Loss account statements etc) or Audited Annual reports in support of clause no. 1 (b) above.

All the above financial data has to be duly certified by certified accountants e.g. Chartered Accountants (CA). The financial data and documents certified by any other authority shall not be accepted.

- 4. The bidder firm shall submit the copy of PAN and GST Registration Certificate.
- 5. Other Eligibility requirements for the Bidders:
- (a) The bidder shall provide names of organization(s)/ firm(s) with addresses and telephone numbers, fax numbers, e-mail addresses for which they have manufactured and supplied such *Cylinder Mould Multi-Tonal Water marked Paper* during the last five years, if any.

- 1.2 The bidder, their affiliates or subsidiaries- including subcontractors or suppliers for any part of the contract-should not stand declared ineligible/ blacklisted/ banned/ debarred by any Government Agency anywhere in the world, for participating in its tenders, under that country's laws or official regulations. A declaration to this effect shall be submitted by the bidder in the Tender Form (Section III).
- 1.3 Unless otherwise stipulated in the NIT/SIT, joint Ventures/ Consortiums shall not be considered in this tender.
- 1.4 Under Public Procurement (Preference to Make in India) Order 2017 (as amended/ revised from time to time) any Nodal Ministry for its items may issue directions to exclude bidders from a country from eligibility for its procurement as measure of reciprocity of such action by that country against Indian Suppliers.
