2. Terms of Delivery: FOR BNP Dewas
3. Offer should be valid for 120 days. The tender shall be opened as and when received.

 - d) If equivalent item are offered against the requested item guarantee to the effect has to be given.

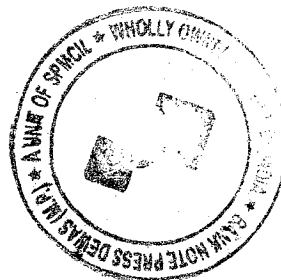
