I) Technical Specification of Poly Schablon Plates

Size : 765 mm X 840 mm

Thickness : 2.30 mm

Polymer Thickness : 2.00 mm

Plate Hardness: 27 Shore D

General requirements :

The supplier should be note that the material which will be supplied meets following requirement:

Digital photopolymer (Nyloprint) Poly Schablon Plate for Computer to plate (CTP) water washable plant for inking the intaglio plates during security printing on high speed KBA and Komori intaglio printing machines for long run.

- 1) The plate shall consist of light sensitive photopolymer material firmly pasted to base material.
- 2) The plate should be suitable for producing image having resolution of 8000 dpi & above.
- 3) Plates shall be washable in water only during developing.
- 4) Dimensional stability of the plates should be very high.
- 5) There should not be data loss during plate reproduction.
- 6) To examine the digital photopolymer plates during developing, proper visibility is essential to differentiate the relief area and base of the plate.
- 7) The Polyschablon plates should have uniform thickness of 2.30 mm and should be suitable for processing in Kodak Thermoflex Mid II UHR CTOP machine & Jura Super SecuDry CTP and compatible with Flint group Nyloprint Point Light Exposure frame FII machine, De La-Rue Giori Polyexpo machine & Nyloflex Combi F III and Flint group nylo print wash-out system DWT 90 oT & Nylo print flowline washer DWT 100.
- 8) Plates should be capable of Laser Diode exposing in Kodak Thermoflex Mid II UHR CTOP machine and seculas/Jura Super SecuDry CTP machine.
- 9) After drying and post exposure, the plates shall have very good resistance to the wear and tear and image breaking.

- 10) The unserviceable plates should be suitable to be defaced by hot water by peeling off the polymer coating easily and there should not be any rust formation on the bare metal surface.
- 11) Plates should be free from oil and greasy substances on the light sensitive coating and should not be sticky to prevent clogging of laser head, pipe lines and filter of dust collector system in CTP machine.
- 12) Waste water produced during processing of the plate should be environment friendly.
- 13) Plates should have good resistance to wear and tear after post exposure and drying.
- 14) Plate should be supplied in the original packing of the manufacturer.
- 15) Packing should be robust enough to withstand the pressure during handling and transportation.
- 16) Corners of the plate should not bend while mounting on the plate cylinder.
- 17) Shelf life of the plates should be minimum two years from the date of delivery.
- 18) The supplier should enclose MSDS certificate/Safety Data Sheet.
- 19) The supplier should enclose the certificate from the manufacturer that the plate is suitable for reproducing image having resolution of 8000 to 10160 dpi.

B) Packing :-

- 1) The plate should be supplied in original packing of the manufacturer and should be sufficient to protect from light exposure and water. One box should contain 10 plates only.
- 2) The packing should be robust enough to withstand the pressure during transportation and handling.
- 3) The packing should be duly labelled with complete description of the product inside along with manufacturing date .
