SECTION VII: TECHNICAL SPECIFICATIONS **SPECIFICATIONS & GENERAL SCOPE OF WORK**

- 1) Job work of complete dismantling of all the components of machine, checking all the parts for the extent of wear, re-assembly of the parts with repaired / new one as arranged by CNP, After complete re-assembly, setting and extensive production trial of the machine.
- 2) The firm has to deploy specialized skilled experienced manpower and no. of sufficient labor for the said job work. CNP will not provide any manpower for the execution of said job work.
- 3) For the job work all the required special tools and special fixtures needed if any are to be arranged by the firm.
- 4) The firm's specialized skilled experienced manpower and no. of sufficient labor have to work in close co-ordination & interaction with concerned Electrical and Mechanical officials for effective time under the close supervision of firms project manager / Supervisor.
- 5) The firm's engineers & technicians may visit CNP with prior permissions to assess the scope of work in detail, for special fixtures & tools if any needed for the execution of said job work and space limitation to work etc. before submitting the quotation.
- 6) All the required repaired parts or new spares required to be used on machine during assembling will be provided by CNP.
- 7) While executing the job work of dismantling and assembling all the Electrical connections on machine will be taken out and re fitted again along with required spares by Electrical officials of CNP.

9) After completion of assembling work, complete setting work will be executed in co-ordination with Technical, workshop Electrical and Mechanical officials posted on the machine. Extensive production working trial will be conducted in presence of CNP officials for one week.

10) After sufficient trial Gantry dismantling, all machine guards fitted and machine area to be perfectly cleaned by the firm.
