#### MINIMUM ELIGIBILITY CRITERIA

The following shall be the minimum eligibility criteria for selection of bidders:

#### 1. Experience and past performance:

The bidder i.e. Manufacturer or Supplier should have supplied at least similar type of material for an order value of Rs.1,16,200/- in any one year during last 5 years ending 31.03.2021.

# 2. Financial Standing:

- (a) Average Annual turnover of the bidder firm should be more than Rs. 1,16,200/- during last three years i.e. 2018-2019, 2019-2020 and 2020-2021.
- (b) Bidder firm should not have suffered any financial loss for more than one year during the last three financial years i.e. 2018-2019,2019-2020 and 2020-2021.
- (c) The net worth of the firm should not be negative and should not have eroded by more than 30% in the last three financial years i.e. 2018-2019,2019-2020 and 2020-2021.
- 3. The bidder should submit Power of Attorney of the Authorized Signatory for signing the bid, entering in to contract, if awarded and for any other correspondences.


