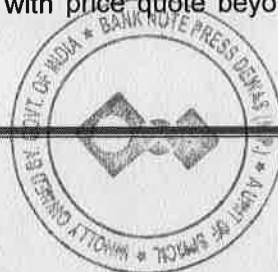

**SIT 1: Eligible Goods:** All goods to be supplied under the contract shall have their origin in India or Indian Agent in case of imported item, subject to any restriction imposed in this regard in Section III (SIT). The term "origin" used in this clause means the place where the goods are mined, grown, produced, or manufactured or from where the related services are arranged and supplied.

**SIT 2: Clarification of Tender Documents:** A Tenderer requiring any clarification or elucidation on any issue of the tender documents may take up the same with BNP DEWAS in writing or by fax / e-mail/ post. 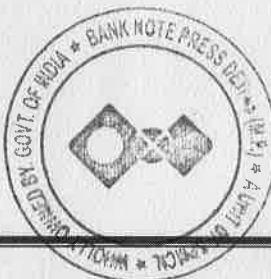

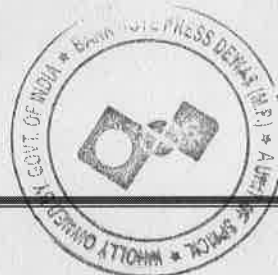

### SCC - 1: Packing and Marking:

The quality of packing, the manner of marking within & outside the packages and provision of accompanying documentation shall strictly comply with the requirements as provided in Technical Specifications and Quality Control Requirements under Sections VII and VIII and in SCC under Section V. Therefore, the suppliers have to produce all the Bank details such as - Name of Bank, Account No., IFSC Code No., MICR No. along with the Tender Document.

**SCC-9: Quantum of Liquidated damages :** If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, BNP DEWAS shall, without prejudice to other rights and remedies available to BNP DEWAS under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the **½% (0.5%) percent+ 18% GST** (or any other percentage if prescribed in the SCC) of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the **10% percent+ 18% GST** (or any other percentage if prescribed in the SCC) of the delayed goods' or services' contract price(s). During the above mentioned delayed period of supply and / or performance, the conditions incorporated under GCC sub-clause **23.4** shall also apply.

**SCC-10: Resolution of disputes:**

If dispute or difference of any kind shall arise between BNP DEWAS and the supplier in connection with or relating to the contract, the parties shall make every effort to resolve the same amicably by mutual consultations. If the parties fail to resolve their dispute or difference by such mutual consultation within twenty one days of its occurrence, then, unless otherwise provided in the SCC, either BNP DEWAS or the supplier may seek recourse to settlement of disputes through arbitration as per The Arbitration and conciliation Act 1996 as per following clause.

**SCC-11: Arbitration Clause:** All disputes & differences arising out of or in any way touching or concerning this agreement (except those for which specific provision has been made therein) shall be referred to Sole Arbitrator to be appointed by CMD, SPMCIL. This contract has to be interpreted in accordance with the laws of the Union of India and arbitration proceedings shall be conducted in India under the Arbitration and conciliation Act 1996. The Arbitrator so appointed shall be an SPMCIL Officer who had not dealt with matters to which this agreement relates and in course of his duties had not expressed views on all or any of the matter in dispute or differences. The Award of the Sole Arbitrator shall be final and binding on the parties.



**SCC-12: Failure & Termination**

A) Cancellation of contract for Default: Without prejudice to any other remedy for breach of contract, like removal from the list of registered supplier, by written notice of default sent to the supplier, the contract may be terminated in whole or in part:

- (i) If the supplier fails to provide any or all the goods within the time period (s) specified in the contract, or any extension thereof granted
- (ii) If the supplier fails to perform any other obligation under the contract within the period (s) specified in the contract or any extension thereof granted.

B) Termination of Contract for convenience: Bank Note Press, Dewas (M.P.) may at any time terminate the Contract by giving you one month's prior notice in writing to that effect and shall have the liberty to appoint any other agency to carry out your obligations under this Contract.

**SCC-13: Force Majeure:**

13.1 In the event of any unforeseen event directly interfering with the supply of stores arising during the currency of the contract, such as war, hostilities, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts, or acts of God, the Contractor shall, within a week from the commencement thereof, notify the same in writing to the Purchaser with reasonable evidence thereof. Unless otherwise directed by in writing, the supplier shall continue to perform its obligations under the contract as far as reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

If the force majeure condition(s) mentioned above be in force for a period of 90 days or more at any time, either party shall have the option to terminate the contract on expiry of 90 days of commencement of such force majeure by giving 14 days' notice to the other party in writing. In case of such termination, no damages shall be claimed by either party against the other, save and except those which had occurred under any other clause of this contract prior to such termination.

13.2 Notwithstanding the provisions contained in GCC clauses 23, 24 and 26, the supplier shall not be liable for imposition of any such sanction so long the delay and/ or failure of the supplier in fulfilling its obligations under the contract is the result of an event of Force Majeure.

13.3 In case due to a Force Majeure event is unable to fulfill its contractual commitment and responsibility, BNP Dewas will notify the supplier accordingly and subsequent actions taken on similar lines described in above sub-paragraphs.

## SECTION VII: Technical Specification & Scope of Work

### DECANTER CENTRIFUGE MACHINE – Qty. - 2 EA (ALDEC 30 or equivalent)

Application: Dewatering of Ink Sludge

Technical specifications of Decanter:

The decanter machine should be of the open casing, non-pressure tight horizontal design. It should be consist of a solid horizontal bowl and helical scroll conveyor, with a counter current process flow configuration. The centrifuge should be designed and built to operate continuously and at speed of 4400RPM with process material having a solids phase density up to 1200 kg/m<sup>3</sup>. In Decanter all process contact parts of the centrifuge should be of type AISI 316 stainless steel or better with the exception of seals, "O" rings and hard surfacing. Process seals and O-rings should be made of nitrile rubber or neoprene.

Decanter Frame and Casing Assembly

Frame

The main frame parts should be made of mild steel box beams connected with cross beams where the main bearings are placed.

The main drive motor should have either flange mounted on an adjustable plate or placed on a motor shelf and fitted with vibration dampers. The drive motor is located either between the two legs at the solids discharge end of the decanter or inline to one side at the solids discharge end. The back drive should be placed on the frame in line with the gearbox. The frame should be mounted on rubber type vibration damper isolators.

Casing

The lower part of the casing should have either be an integral part of the frame or a separate fabrication. The liquid outlet and the solids outlet should be located between the two box beams. The compartment between the outlets the casing should be consists of a plate sloping towards the liquid end. The casing should have either of stainless steel fabrication or carbon steel with product discharge area cladding by AISI 316 stainless steel. The cover should be made of stainless steel SS316 with a nitrile rubber gasket seal. The baffle in the casing should prevent entrance of liquid and solids into the central compartment of the casing.

Process Connections

The feed tube should be fabricated from AISI 316 stainless steel and feed connection should be a hose connection with optional flex connection and flange adapter. Polymer addition at the feed tube should be possible. Cake and cent rate discharge should have of rectangular bolted flange type

Main drive

The main drive motor should have a high efficiency IE3 minimum with 4 or 2 pole motor either flanged or foot mounted on to a motor mounting assembly enabling simple belt tensioning. Power is transmitted from the motor pulley to the bowl pulley via V-belts.





## Back drive Assembly

The back drive mounting on the decanter frame should be in-line & countershaft design, coupled to the gearbox via a flexible coupling. Its countershaft design should have conveyor overload sensor & GS clutch mechanism to stop the decanter in case of overloading.

## Belt Guards and Gearbox Covers

Guards and covers should be of painted carbon steel or fiberglass.

## Assembly

### Bowl Assembly

The bowl assembly should be manufactured from 316 SS material. The decanter bowl should be consisting of a cylindrical section plus a conical beach extension with cone angle 10 deg. The bowl shell should be manufactured from centrifugally cast stainless steel with a corrosion resistance equivalent to that of AISI 316. Prior to final machining, all surfaces must be examined for cracks, shrinkage, porosity or other defects by means of liquid dye penetrant test. The centrifuge bowl is 1260 mm long (from hub to hub) with an inside diameter of 280 mm in the cylindrical section. The bowl should be mounted on rolling element bearings with a minimum rating according to L10AAH of 100,000 hours when balanced and assembled to the manufacturer's specifications. All bearings must be lubricated by solid grease. The liquid level should be controlled by plate dams located at the large diameter end of the bowl where the liquid is discharged. The plate dams should be retained with backing plates and sealed with nitrile rubber gaskets.

### Conveyor Assembly

The conveyor should be fabricated from AISI 316 SS and is equipped with single lead windowed quasiaxial flights. The conveyor should be made out of Centrifugal casting of SS316. The conveyor flights should have a thickness of 6 mm minimum and material grade (AISI 316) making the fabrication rigid enough to transmit the high loads necessary to convey high dry solids cake from the bowl. The conveyor should be concentrically suspended within the centrifuge bowl by low friction rolling element bearings, lubricated from external fittings that are accessible for necessary maintenance. The feed zone should be of a high capacity design with field replaceable hard surface tungsten carbide wear protection.

### Gearbox

The gearbox should have multi stage planetary gear reducer unit, which provides the high torque necessary to maintain the differential speed between the centrifuge bowl and conveyor whilst discharging a high shear strength low moisture cake. The gear unit should have a torque capacity depending on size and application.

Gears should meet AGMA Class 10 and 11 requirements and the sun and planetary gears should be case hardened and ground. Lubrication should be self-contained, using high performance synthetic gear oil.

The individual stages of the gearbox and the body should be balanced as components prior to assembly.  
Protection





### Tungsten Carbide Hard Facing

The conveyor flights should be protected with flame sprayed sintered tungsten carbide coating on the flights from the solids discharge end to past the feed zone.

### Bowl Shell Wear Protection

The bowl should have stainless steel SS316 strips to secure proper solids conveying and to protect against abrasion. The solids discharge area should be protected with field Casing Covers should be manufactured in Duplex, SS 316 or SS 304 for better resistance against pitting /erosion and due to high impact of discharged phase & also to prevent corrosion.

The patented feed zone design in the decanter centrifuge should be of "Esberg Design" to facilitate the flow of incoming slurry in tangential direction to the pool of liquid inside the machine. So that helps to minimize the turbulence and disturbance in the existing pool of liquid inside the machine.

Windows cut out in the conveyor flights should be aesthetically fabricated following good manufacturing practice as per the flow dynamics design to achieve the quasi axial flow and minimize turbulence. Machine should be offer with fitted 2 stage planetary gear box for optimum performance. Larger gear boxes used for higher torque generation which leads to convey heavier solids.

Special Frame fabricated from the MS box section should be provided, giving operational height to the machine. Hence no additional civil structure should be required for achieving operating height. Decanter machine should be highest G Force than any other machine available in today market and the setup & process allows to keep close tolerance & to operate higher Speed with moderate maintenance.

Decanter should have V belt pulley arrangement from main drive side enables to operate on reduced operational speed.

In Decanter machine Solids Discharge outlet should be fitted with Tungsten Carbide inserts. So these inserts will help to reduce wear and tear on bowl and improves the life of the bowl. Decanters should be fitted with Power Tubes for easy adjustment of liquid level on site. Decanters should have Counter Current flow arrangement for east & effective separation. Decanter centrifuge should have compact designed for maximum economy of space. Driving Motor should be mounted (Flange) on frame enables to keep Motor & centrifuge axis vertically parallel to achieve Compact Design , also all said features should be ultimately helping for the safety, optimum performance and long- trouble free operation of the decanter centrifuge for the sludge dewatering application. Replaceable Tungsten carbide / stellite wear bushings or tungsten carbide saddles.

### Casing Protection

The solids outlet area of the casing should be erosion protected by a stainless-steel wear liner.  
Paint

The standard paint should be high build epoxy base primer with a high gloss two pack polyurethane top coat.

An emergency stop should be located on the centrifuge frame and wired back to a common control terminal in an IP65 enclosure.

Quality Assurance

Balancing

During manufacture of the bowl, the conveyor and the gearbox should be balanced individually before assembly. The components are balanced to a quality level of 2.5 according to the ISO1940 standard.

## Vibration level

The general shop vibration acceptance level should be maximum 6 [mm/s r.m.s.] measured at the main bearings. A maximum vibration level of 8 [mm/s r.m.s] can be accepted on some decanter variants but only if a quality level of 2.5 according to ISO1940 is fulfilled for each main component.

## Documentation

### Instruction manuals

The instruction manuals for decanters should be provided in a number of volumes and be available in the main languages.

Installation data (ID). This volume should contain general information and recommendations. It also includes a dimensioned drawing and wiring diagrams.

Operator's manual (OM). This volume should contain operation and service information as well as instructions for disassembly and reassembly.

Spare parts (SP). This volume should contain the spare parts list whereby almost all parts of the decanter can be identified by their part number.

## Tools

### Standard Supply

Specialist tools should be provided with each decanter where necessary to undertake normal maintenance such as wear inspection, lubrication and drive belt tensioning.

### Optional Tools

Suppliers should take all the essential equipment's used during installation process.

Spare parts availability and services of machine must be declared by suppliers.

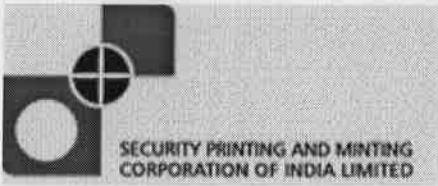

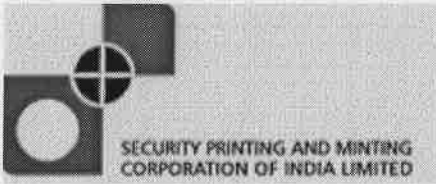

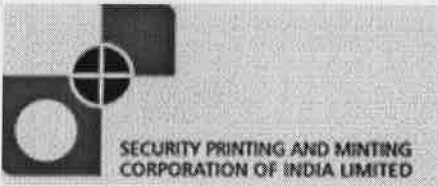
