1.0 With reference to above, it is to inform that, Currency Note Press, Nashik Road has placed purchase order no. 4500017179 dtd: 18.09.2019 for supply of 02 sets of upper and lower cutting knife with carbide tip with delivery period upto 15.07.2020 with pre production sample clause for exactly matching the technical specifications.

2.0 Subsequently, CNP vide letter dtd: 31.01.2020 reminded the firm to supply first lot of carbide tip cutting knife to CNP, in reply to which the firm requested to provide time upto 31.03.2020. Further, CNP reminded the firm vide emails dtd: 16.06.2020, 22.06.2020 and 09.11.2020 but the firm failed to reply. CNP has issued show cause notice to the firm under reference no. 4 above, to which the firm has failed to reply within stipulated time.

3.0 Hence, in line with terms and conditions of referred purchase order and SPMCIL procurement manual, M/s. Universal Engg. & Mfg. Industry, Pune stand Blacklisted from participating in any of the tender of Currency Note Press, Nashik Road and all other units of SPMCIL for the period of next 01 year w.e.f. 12.06.2021.
