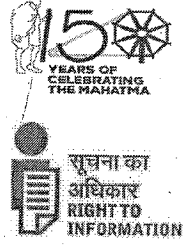

This is with reference to deliberate attempts to pass off inferior goods, supply of short quantities of Block board boxes and not supplying the material as per the delivery schedule against PO no.4500016711 dated 13.05.2019 to BNP, Dewas in spite of enough opportunities given to the firm.

2. In line with the terms & conditions of tender and SPMCIL Procurement manual guidelines, your firm stands blacklisted from participating in any of the tender of Bank Note Press Dewas and all other units of SPMCIL for a period of three years wef 08.03.2019 to 07.03.2022 for failure to supply the material as per the delivery schedule of PO and not supply the material as per technical specification mentioned in the tender.

3. The said purchase order no. 4500016711 dated 13.05.2019 is hereby stands cancelled at your risk and cost. Further, Security Deposit submitted in form of BG for Rs.9,13,500 against the referred PO stands forfeited. Also, M/s Ashok Industrial Agencies (P) Ltd has been removed from the list of registered vendor of BNP Dewas.
