Title: Supply, Installation, Testing and Commissioning of Automatic Assembly Line for Packing with Conveyor.

1. Brief Intent of Requirement:

Currency note press is engaged in printing of currency/bank notes and converted into the finished product. After printing the sheets are fed to the final assembly line for processing. At final assembly line the sheets are cut and packed in the form of bundles for dispatch. Further these bundles are loaded on the trolley and sent for final packing section. Now CNP intends to make a complete assembly line to pack these bundles in the box. Afterwards the box should have to mention the denomination, prefix no., Machine no., Date & Time. The complete box has to be nailed and strapped. After completion of process the box should be unloaded on a trolley or pallet for internal movement.

The EOI submitted by the firm should cover the following:

- a) Detailed technical specifications in details of the proposed facility/system.
- b) Layout and dimensions of the proposed equipment's / system.
- c) Budgetary offer shall be submitted after site visit & finalization of scope of work and specifications
- d) Process flow chart.
- e) Time required for successful installation and commissioning of the equipment.
- f) The participating firm must provide after sales service for at least 10 years for satisfactory performance of the equipment/ system.

Important Instructions to Bidders:

1. The participating bidders shall be required to submit all related technical details, capabilities of the firm, product catalogues, and specifications of the proposed system, technical write up and presentation (if necessary) on the proposed equipment/ system and experience on manufacturing and supply of similar machines.
2. The interested firm has to visit the site for understanding the requirement.
3. The intending supplier will also be asked to provide after-sales support for maintenance for 10 years for satisfactory performance of the system.

4. The Bidders should give a declaration that they have not been blacklisted or debarred for dealing by Government of India or any Government in the past.
