Section VII: Technical Specifications

1.0 <u>Scope of Work:</u>

1.1. Scrap is to be cut in to pieces of not larger than 45 cm x 45 cm x 45 cm size. Weight of each piece must not exceed by more than 200 kgs and if weight of 45cm x 45 cm x 45 cm size pieces exceeds 200 kgs size should be reduced accordingly to 200 KG criteria. Cutting weight will be considered on actual basis.

1.2. The structure of the scrap is in dismantled form. The MOC (Material of Construction) of scrap is ferrous and Non Ferrous.

1.3. The cutting will be done through Electric Arc/Gas cutting / or any other suitable environmentally friendly mode.

1.4. The complete operation of cutting may have to be done in presence of representative nominated by CNP.

1.5. The contractor shall make their own arrangement for cranes/chain, pulley, tools, tackles fork lifters, handling equipment and all other related equipment including complete manpower.

1.6. The contractor should take necessary safety precaution like providing PPE, to his employee during entire cutting work. CNP will not be responsible for any accident occurred to any person engaged in the work.

1.7. Contractor shall use the CNP facilities available only after prior approval from competent authority of CNP.

1.8. The Contractor shall get power supply from the CNP at one point at work site, the power supply shall be chargeable basis.

1.9. The contractor shall obtain necessary prior permission from the safety and fire authorities of CNP for carrying out any welding and gas cutting work. No welding /cutting work should be done in absence of CISF and Fire unit representative.

1.10. Necessary entry passes for the men and material deployed shall be arranged by the contractor from CNP authority. All the requirements to prepare the entry passes of the persons e.g. photograph, voter ID card, police verification etc shall be fulfilled by contractor.

1.11. All person or labour shall follow all security norms of CNP and shall go through the searching as per the procedure of CISF.

1.12. The contractor can inspect the site with prior permission and acquaint themselves with the nature of works involved before submitting their offer.

1.13. The contractor shall carry out the work without any hindrance to our daily routine work.

1.14. Payment terms: Payment shall be done on running bill basis after completion of each 100 MT of works. The firm should submit bills after completed work as per scope of work for 100 MT quantities which shall be duly certified by CNP officials and 90% payment of the certified bill shall be made within 30 days. Remaining 10% of each bill shall be paid along with final bill



after satisfactorily completion of complete work as per scope of tender.

1.15. The quantity of the work indicated above i.e. 300 MT (+/-10%) approximately and payment shall be done on actual quantity which shall be recorded by CNP at its own weighing machines.

1.16. Ferrous and non -ferrous material should be segregated.

1.17. Weighing machine will be provided by CNP at the site of cutting for weighing purpose.

1.18. After cutting of scrap pieces will be kept only at the placed earmarked by CNP.
