- a) This EOI is only for India Manufacturers/bidders/suppliers, for this purpose, a supplier or bidder shall be considered to be from a country if:
 - (i) The entity is incorporated in that country, or
 - (ii) a majority of its shareholding or effective control of the entity is exercised from that country or
 - (iii) As per the Public Procurement (Preference to Make in India) order 2017 (PPP-MII) and its subsequent amendments/revisions.

- b) Ministry of Finance, Deptt. of Expenditure, Public Procurement Division's Order (Public Procurement 1,2 and 3) F.No.6/18/2019-PPD dated 23rd/24th July 2020 (or any amendments thereof) regarding eligibility of bidders from specified regions shall be applicable to all procurements. Any bidder from a country which shares a land border with India (excluding countries as listed in the website of Ministry of External Affairs, to which the Govt. of India has extended lines of credit or in which the Govt. of India is engaged in development projects) will be eligible to bid in any procurement whether of goods, services (including consultancy services and nonconsultancy services) or works (including turnkey projects) only if the bidder is registered with the registration committee constituted by the Department for promotion of Industrial and Internal Trade (DPIIT).
- c) The intending bidders shall submit all technical details, capabilities, and experience for supply, installation, commissioning of Fire Resistant Precious Metal Protection Cabinets and Strong Room Door with Intelligent Alarm System.
- d) The bidders should give a declaration that they have not been blacklisted or debarred for dealing by Government of India or any Government/PSU/Reputed organization in the past.
