STATEMENT OF REQUIREMENTS (SOR):

IGMM is in the process of renovating/modernizing the shop floor/office including modern storage and security aspects of functions of manufacturing of precious metal Coins, Medal, and Gold & Silver Refining. Therefore the EOI is invited from prospective firms of consultancy for the following scope of works to make a state-of—the art infra facility for above mentioned functions:

- a) Layouts demarking the area for Renovation & Expansion.
- b) Layout Plan Indicating various process zones, security/ screening areas, stores, toilets, services spaces etc.
- c) Schematic Plans schematically indicating equipment, service trenches and movement/circulation.
- d) Material finish references and flooring plan.

- e) Lighting and Ceiling Plan.
- f) Sketch's/ references images indicating the overall look and feel of the space. (Non-Commercial 3D)
- g) Earmarking for Maintenance Area.
- g) Security Check, Uniform changing room, Area for washroom & water filter collation, Food arrangement (Pantry), Auxiliary Machines (tool room).
- h) Storage facilities for Precious Metal.
- i) Fresh air, AC (Ventilation), Inert Gas provision (pipelines), Pneumatic/ LPG Gas connections, Electric cables, Exhaust arrangement.

10. Pre-Qualification Criteria

- a) This EOI is only for Indian firms for this purpose, a service provider or consultancy house shall be considered to be from a country if:
 - (i) The entity is incorporated in that country, or
 - (ii) A majority of its shareholding or effective control of the entity is exercised from that country or
 - (iii) As per the Public Procurement (Preference to Make in India) order 2017 (PPP-MII) and its subsequent amendments/revision issued by Government of India from time to time
- b) Ministry of Finance, Deptt. of Expenditure, Public Procurement Division's Order (Public Procurement 1,2 and 3) F.No.6/18/2019-PPD dated 23rd/24th July 2020 (or any amendments thereof) regarding eligibility of bidders from specified regions shall be applicable to all procurements. Any bidder from a country which shares a land border with India (excluding countries as listed in the website of Ministry of External Affairs, to which the Govt. of India has extended lines of credit or in which the Govt. of India is engaged in development projects) will be eligible to bid in any procurement whether of goods, services (including consultancy services and non-consultancy services) or works (including turnkey projects) only if the bidder is registered with the registration committee constituted by the Department for promotion of Industrial and Internal Trade (DPIIT).
- c) The intending bidders shall submit all technical details, capabilities, and experience providing the services of renovating and capacity expansion in precious metal (Gold & Silver).
- d) The bidders should give a declaration that they have not been blacklisted or debarred for dealing by Government of India or any Government/PSU/Reputed organization in the past.
- e) The documents in support of Expression of Interest need to be submitted duly signed by authorized representative of the company.
- f) The interested bidders should also submit alongwith the Expression of Interest a list of parties to whom they provided similar services of renovating and capacity expansion in precious metal (Gold & Silver) with details and performance report from their clients.

- g) The bidder should also submit EOI alongwith supporting documents with respect to having provided similar type of services of renovating and capacity expansion in precious metal (Gold & Silver).
- h) The interested bidders shall also submit copies of Audit Financial Statement for the last five years 2016-2017, 2017-2018, 2018-2019, 2019-2020 and 2020-2021.
- 11. The Interested Bidder should submit the Budgeted Quotation for the services required in point No.9.
- 12. The bidder should also confirm specifically that:
 - a) Applicant is competent and legally authorized to submit and/or to enter into legally binding contract.
 - b) The details of providing services of similar work of renovating and capacity expansion in non-coinage area/precious metal (Gold & Silver) by the firms during last five years i.e. 01st ending of March 31, 2022.
 - c) The firm should confirm their annual services of providing similar services of renovating and capacity expansion in non-coinage area/precious metal (Gold & Silver)
 - d) Applicant will absolve the purchaser against any infringement of patent rights and other contract provisions.
