10. Brief Intent of Requirement:
 - 10.1 The Currency Note Press (CNP), a unit of Security Printing & Minting Corporation of India Ltd. located at Nashik is engaged in printing of currency/ bank notes and is in requirement to procure "Design, Supply, Installation and Commissioning of reputed make/ brand Automatic Storage and Retrieval System (ASRS) for storing CWBN paper, WIP Printed paper and finished product in CNP. In some of areas of CNP, the ASRS system is required to work on the logic of FIFO and in finished product area the required storage and retrieval will be in the lot of 10 boxes, however, total lot will be retrieved at a time in random manner.
 - 10.2. Submitted EOI by the bidder should cover the following:

- (a) The participating firm should categorically mention the detailed composition of the proposed ASRS system and its auxiliary along with the Make & Model of the system being offered. Detailed Technical specifications of the proposed ASRS system, product catalogues and technical write up and presentation (if necessary) on the proposed equipment/ system and experience on supply of similar.
- (b) The participating firm should mention specifically if anything which is not covered within the scope but essential to operate the system. If not mentioned, that should be supplied by the bidder.
- (c) The participating firm can supply any superior system which meets the actual operational and functional requirement of Currency Note Press.
- (d) The bidder should provide comprehensive Warranty for ASRS system for one year.
- (e) Layout and dimensions of the proposed equipments of the system.
- (f) Customers List and performance certificate of their installed equipment from the customers.
- (g) Budgetary offer for the proposed system must broadly include taxes/ duties FOR Currency Note Press, Nashik basis.
- (h) Technical Manual of ASRS system, flow chart for the entire system in details with its capabilities.
- (i) Details of the plan for successful installation and commissioning of the ASRS system along with time period.
- (j) The participating firm must provide after sales service for at least 10 years for satisfactory performance of the equipment/ system.

11. Important Instructions to Bidders for submission of the documents:

- (a) The interested firm has to visit the site for understanding the requirement.
- (b) The participating bidder shall have carried out the similar project in last 3 years i.e. end of March-2021. The firm shall provide purchase order copies of the customers to whom such equipment/ system have been supplied in the past 03 years i.e. end of March-2021 with details of the equipment/ system and their addresses along with phone, fax and email addresses and performance report from them.
- (c) The participating bidders should give a declaration that they have not been blacklisted or debarred for dealing by Government of India or any Government in the past.

- (d) The documents in support of Expression of Interest need to be submitted duly signed by the authorized representative of the applicant with name and designation of the signatory.
- (e) The documents in support of Expression of Interest (viz. Supply order details/ Installation Certificates/ Performance Report and List of Customers along with addresses & contact numbers to whom they have supplied such equipments/ systems) need to be submitted duly signed by authorized representative of the applicant.
- (f) The intending supplier will also be asked to provide after sales support for maintenance for 10 years after warrantee for satisfactory performance of ASRS system.
- (g) The bidder shall fill and submit the format provided at Annexure-"A" along with this document.
- (h) The principal bidder will have to directly participate in this EOI. Participation of any authorized firm by any principal bidder will not be considered.
- (i) Bidders are requested to submit Budgetary Quotations for the product which they intent to quote along with EOI.
- (j) The bidder/applicant should submit the detailed brochures/ leaflets/ specification of this system.

12. Procurement Process:

Following are the details of this procurement process:

- i. At first, the Expression of Interest is being floated for above mentioned system.
- ii. The firms intending to participate in the EOI have to present a detailed presentation at CNP, Nashik regarding their offers of services/goods and the cost for such visits shall be borne by firms only.
- iii. After evaluation of the responses received, a Tender will be floated incorporating all the terms and conditions, specification as per buyer's requirement. An Open tender will be floated for active participation of bidders.

13. The Bid shall be submitted in English Language only. The Authenticated copies of the documents in support or applicant's claim may be submitted in English Language.

14. The bidders will be required to give a presentation of the offered item by them on mutually agreed date after submission of the offer.
15. The bidders shall provide copies of balance sheet, Profit & Loss statement, of last Five years ending March-2021. If Financial Year maintaining calendar year wise then up to December-2021. All the Financial data to be certified by Charter Accountant in India and certified by Public Accountant in foreign as the case may be.
16. The bidders shall enclose details of quality accreditations received by them.
17. The dully filled details along with supporting documents should be sent in a sealed envelope super scribing "Expression of Interest for Procurement of Portable Banknote Printing Quality Measuring Device (Densitometer/Spectrophotometer) in CNP, Nashik Road".
