CLEXTRAL SUPPLIED NEW PULP PLANT AT SPM NARMADAPURAM) ON TURNKEY BASIS</p> <ol style="list-style-type: none">The storage tank design should ensure that pump discharging is smooth and no dead angles exist; the pulp materials in the tank rotate with the centre,Proper stirring device shall be mainly for the pulp materials in the tank to avoid flocculation of the pulp material.Tank system shall be free of dead angles, uniformly stirring smooth in pump discharging and convenient and fast to flush.The stirring device is convenient to maintain and detach and high in efficiency.Supplied Tank construction should be stress relieved, free from fatigue.MOC selection for all the equipment's should be capable to handle working temperature minimum 100°C, and hazardous chemical substance of H₂O₂, NaOH & H₂SO₄.Construction should be strong enough to handle continuous turbulence pressure of 7-8% consistency cotton pulp due to agitation.Even dilution and stable mixing process without consistency variations.Arrangement to avoid fermentation zone, briquetting and segmentation of medium consistency cotton pulp.Nos. of pumps & agitators should be consider for 24X7 operation process and for the ease of maintenance without interrupting supply in case of breakdown.Material of construction for all tanks is SS 316 L.
