Background of the company

Security Printing and Minting Corporation of India Limited (SPMCIL) is a Mini-Ratna Category-I CPSE and a wholly owned schedule 'A' Company of Government of India and is under the administrative control of Department of Economic Affairs, Ministry of Finance, Government of India. SPMCIL is engaged in the manufacture of currency/security paper, minting of coins, printing of banknotes, non-judicial stamp papers, postage stamps, travel documents, etc. having nine units including four mints (India Government Mint-Kolkata; India Government Mint-Hyderabad; India Government Mint-Mumbai and India Government Mint-Noida), two security presses (India Security Press-Nashik and Security Printing Press-Hyderabad), two currency presses (Currency Note Press-Nashik and Bank Note Press-Dewas) and one paper mill (Security Paper Mill-Hoshangabad) across the country.

Objective: 1.

Procurement of Supply, Installation, Testing and commissioning and erection of sewage treatment plant at BNP Colony Dewas with operation and maintenance for 5 years.

Brief Description of work Í.

BNP Dewas intents to procure for Supply, Installation, Testing and commissioning and erection of sewage treatment plant at BNP Colony Dewas with operation and maintenance for 5 years.

1 No. Quanntity

Scope of work:

- a) Biological sewage treatment is a process where biological organisms are cultured and allowed to consume the organic matter and multiply their population. Here, the pollution load is food for the microorganisms. The organisms grow and multiply by a process called binary fission. The multiplied organisms are settled out and the clear treated sewage is free from the organic matter. It is required to erect Sewage Treat Plant of capacity 350 KLD based on biological treatment.
- b) The proposed Sewage Treatment Plant is based on compact extended aeration process. In this plant sewage will be collected in an underground sewage collection tank. Before entering the sewage collection tank, sewage will be passed through a bar screen and oil & grease (O&G) trap for controlling the floating particles and O&G. In the sewage tank, two numbers of pumps shall be provided. One pump shall be working and one will remain as standby. Sewage will be pumped to the inlet channel of aeration.
- c) Aeration tank shall be provided with diffused aeration grid to supply oxygen for biological activity. In aeration, biological growth shall take place and microorganism shall remain in suspended condition. Sewage with MLSS from the aeration tank shall flow into the adjacent clarifier where microorganism shall settle. The settled microorganism shall be recycled to aeration tank and excess sludge will be sent to sludge drying bed (SDB). Sludge cake can be used as fertilizer.
- d) Clarifier water shall be collected in a clarified water storage tank. In clarified water storage tank hypochlorite solution shall be dosed to kill pathogenic bacteria. From the clarified water tank, water shall be pumped to a dual media filter (DMF). The filtered water can be used for gardening and excess water shall be stored in a filtered water storage tank or it will be disposed Off.
- e) Firm shall provide chain-link perimeter fencing around the plant.



f) It is required to provide comprehensive sewage treatment system and maintain the quality of treated water to achieve the following standards as per Water (Prevention & Control of Pollution) Act 1974.

ph	Between	5.5 – 9.0
Suspended solids	Not exceed	100 mg/l
BOD3 Days 27 degree C	Not exceed	30 mg/l
COD	Not exceed	250 mg/l
Oil and grease	Not exceed	10 mg/l
Fecal coliform (MPN/100 ml)	Not exceed	1000

- g) Scope of work includes Operation & maintenance of sewage treatment plant for 5 years after successful SITC of STP. Operational hours of sewage treatment plant is 24 hours in 3 shifts of 08 hours. The firm shall include all maintenance work and cost related to equipment.
- h) Sewage treatment plant shall comply all standards as per Water (Prevention & Control of Pollution) Act 1974.

Firm shall include the following in EOI document:

- a) Schematic Diagram/ Layout of Proposed Sewage treatment Plant.
- b) Detailed Bill of Material along with cost including all necessary equipment, pumps, cables, drives, sensors, flowmeters, electric panel, diffusers, chemicals, FRP pipes / SS pipes. Civil Work i.e. Site clearance, Excavation, RCC, Concreting, brickwork, plastering, painting, epoxy coating, laying of water supply lines, chain-link perimeter fencing, precoated MS sheet shed and installation & commissioning cost etc.
- c) Detailed Delivery period.
- d) Site survey certificate issued by BNP.
- e) Project report including mode of execution of work in detail which should be exhaustive and consist of all design and technical parameters and catalogues of all equipment and installation.
- f) Firm will offer its proposal after considering all the already existing facilities installed at the site. Firm will clearly mention in its proposal whether these facilities will be utilized in its offered model.

Note: The participating firm shall visit the site before expiry of due date of opening of EOI. The site survey certificate will be issued by BNP Dewas and firm has to enclose the same certificate in original along with its EOI document failing which the same shall not be considered.

Experience:

- a. The applicant should have supplied and executed similar type of work across the country during the period of last five years ending on <u>31.03.2021</u>. The details for the same should be submitted along with documentary evidence.
