## **Eligibility Criteria**

#### 1. Status:

The applicant should be either proprietary firm/ Limited Liability Partnership (LLP)/company/Partnership/ (legal entity) registered under relevant regulation of the respective Country. The applicant should be in business of Silk Screen Printing Machine with UV and Thermal curing system including Prepress Software/Equipment for Screen Processing and auxiliaries for application/printing of security Inks and coating on Banknotes.

#### 2. Experience:

- a. The applicant should have supplied similar type of machines across the globe/country during the period of last five years ending on 31.03.2021. The details for the same should be submitted along with documentary evidence.
- b. The interested bidders should also submit along with Expression of Interest a list of parties to whom they have supplied similar type of machines with details and customer satisfaction report from their clients.

# 3. The bidder should also confirm specifically that:

- a. Applicant is competent and legally authorized to submit and/or to enable into legally binding contract.
