NATIONAL INVITATION FOR EXPRESSION OF INTEREST

STATEMENT OF REQUIREMENTS (SOR):

During rainy season water seepage is observed at numerous locations throughout the roof of Factory area, resulting in severe dampness in the adjacent ceiling, walls etc. The same moisture further augments to warping, stains, bubbling and deterioration of the wall texture and its color and hence there is a dire need of a suitable makeover in form of roof treatment in Factory premises. Further, side by side in addition to the dilapidated roof structure there is also an urgency to replace the damaged North light curvature roofing sheet, distorted & rusted MS sheet gutter/funnel, cracked reinforced wire safety glass etc.

Therefore the EOI is invited from prospective firms for the following scope of works for framing up of Technical specifications for Replacement of factory shed along with other associated civil work at India Govt. Mint, Kolkata:

- a) Providing scaffolding system (Cup lock type) with MS tubes to complete the work like roofing, painting, rain water pipe repairing/replacement, dismantling and plastering etc. for factory area of dimension (152X76) in meter approx.
- b) Taking out GCI or asbestos sheets from 10 meter height by making chases in walls as per requirement.
- c) Providing and fixing trapezoidal profile sheet for roof including making lap of new profile sheet with existing AC sheet roofing.
- d) Providing and fixing trapezoidal profile made crimp curve and ridge
- e) Supply and fixing stainless steel wind driven turbo ventilator fan with polycarbonate base to match with the newly fitted trapezoidal profile sheet.
- f) Cement plaster work on above brick work
- g) Taking out old damaged tarfelt from roof, parapet etc.
- h) Hacking on CC flooring to undertake grading works.
- i) Grading works with cement concrete 1:2:4 along with SBR polymer.
- j) Providing and laying 3 mm thick APP membrane.
- k) Taking out damaged MS sheet gutter and Funnel at various places.
- l) Supplying and fabricating with hydraulic power press Valley Gutter/Funnel as per existing design and shape.
- m) Cleaning MS/AC sheet gutter/funnel located at various locations along with disposal of rubbish up to a lead of 100 meter.
- n) Dismantling old plaster or skirting including disposal of rubbish.
- o) Uprooting plants (small, medium, large) of various sizes from wall, parapet surface and making good the surface.
- p) Dismantling SCI rain water pipe of various diameter (like 100,150,200 in mm).
- q) Supply and fixing S&S cast iron pipe of same sizes along with associated fitting like tee, bend as per requirement.
- r) Painting the cast iron pipes of various diameter
- s) Providing and filling the joints with spun yarn/rubber gasket, cement slurry and mortar of pipes of various diameters.
- t) Dismantling steel work at roof
- u) Taking out wind ties from roof
- v) Fixing of old/new wind tie with new fittings.
- w) Structural steel work at roof
- x) Dismantling damaged reinforced wire safety glass panes.
- y) Supplying new reinforced wire safety glass panes.
- z) Painting with aluminum paint on structural steel work (inside factory shed).
- aa) Painting with black anti-corrosive at gutter and structural steel (outside factory shed).
- bb) Applying priming coat with ready mixed red oxide zinc chromate primer on steel surface.

- cc) Disposal of building rubbish/malba/various waste material up to 10 km for all lifts
- dd) Welding by gas or electric.
- ee) Buy- back option for various items like dismantled steel works, GCI or asbestos sheets, SCI rain water pipe, GI sheet make defunct air duct lines.

9. The EOI submitted by the firm should cover the following :

- a. Detail technical specification for replacement of factory shed along with other associated civil work at India Govt. Mint, Kolkata
- b. Detailed project report.
- c. The interested bidders should submit a list of parties to whom they provided similar services of roof replacement with details of phone, fax & email addresses and performance report from their clients.
- d. Time required for completion of the entire job work.
- e. Budgetary Quotation for the services required as per point.9 including taxes/duties FOR India Govt. Mint, Kolkata basis considering the buy-back option.
- f. This EOI is only for Indian firms for this purpose.

10. Important Instructions to Bidders for submission of the documents:

- a. The bidders should give a declaration that they have not been blacklisted or debarred for dealing by Government of India or any Government/PSU/Reputed organization in the past.
- b. The documents in support of Expression of Interest need to be submitted duly signed by the authorized representative of the applicant with name and designation of the signatory.
- c. The documents in support of Expression of Interest (viz. Supply order details/ Performance Certificates/ Addresses of customers and their contact numbers) need to be submitted duly signed by authorized representative of the applicant.
- d. Before submitting Expression of Interest, interested firms can obtain required clarifications/queries from IGM, Kolkata, if any.
- e. The bidders mandatorily must have a site visit in order to check the work as per actual.

11. Procurement Process:


Following are the details of this procurement process:

- i. At first, the Expression of Interest is being floated for framing up of Technical specifications for Replacement of factory shed along with other associated civil work at India Govt. Mint, Kolkata.
 - ii. The bidders participating in this EOI may be called for detailed presentations (if required) and discussions of their service at IGM, Kolkata, the date and time of which may be intimated individually to each firm at their own risk and cost.
 - iii. After evaluation of the responses received, a Tender will be floated incorporating all the terms and conditions, specification as per buyer's requirement. An Open tender will be floated for active participation of bidders.
12. The Bid shall be submitted in English Language only. The Authenticated copies of the documents in support or applicant's claim may be submitted in English Language.
13. The bidders will be required to give a presentation for the service by them on mutually agreed date after submission of the offer and factory visit may be arranged, if required

14. The dully filled details along with supporting documents should be sent in a sealed envelope super scribing "Expression of Interest for framing up of Technical specification for Replacement of factory shed along with other associated civil work at India Govt. Mint, Kolkata". The same may be submitted in person or through courier/ registered post/ speed post so as to reach the following address on or before the prescribed date and time.
