- 5. ## 3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. The firm has to install the antivirus software on server with all configurations and also install antivirus software in remaining 299 desktops & servers. The implementation of antivirus should comply with the technical specifications along with associated software licenses and necessary documents/manuals on site. No additional payment will be done for the installation and configurations.
