## Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity/restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and/or terms and conditions governing the bid. **Purpose:**

The purpose of AMC is to provide periodical preventive maintenance checkup by Atlas Copco(OEM)/ Authorized dealer service engineer to ensure optimum utilization of screw compressor (Type: GA 75 FF) (CFM-462.8)as well as to plan of consumable spare in advance.

**Scope of Work:**

**I. Preventive Service visit:**

The service plan schedule will include the 4 preventive service visit of service engineer periodically and 2 breakdown visit for each compressor. As well as 2 OEM engineer visit (Half Yearly)and 2 No's preventive visit of dryer in a year for both compressor. Generally the work involved will include following points:

1. Checking of the operation of the all safety controls.
2. One overhauling of each compressor in a year.
3. Checking & maintenance of oil cooler & after cooler.
4. Replacement of oil, air filter, oil filter & air oil separator element as per standard time schedule.
5. Checking the working of oil scavenging line & its maintenance.
6. Check the function of all regulating system.
7. Checking & Rectification of all breakdown defects/problem related to Mechanical, electrical & Instrumentation for ensuring smooth running of equipment.
8. Check & recommend any other parameter, which would result in better utilization of the compressors.
9. Provision of All the spares & consumables will be in the scope of SPM
10. Checking, rectification and overhauling of both dryer.

**Electrical scope of work**

- 1- Contractors, overload relay and other thing will be change.
- 2- Motor overhauling can be done on site.
- 3- Checking and tightening of all electrical circuit
- 4- Checking and rectification of all electrical problems.

**II. Break Down Maintenance/ Emergency visit:**

In addition to the quarterly preventive maintenance mentioned above the contractor shall carry out break down maintenance also. In case of break down the service engineer should reach at site within 24 hour wherever a break down is reported to the contractor's office by telephonically/email.

**III. Dryer Maintenance Visit:**

In addition to the maintenance of compressor there shall be Two visit for Compressor dryer unit during contractual period as per SPM requirement.

Firm should ensure the healthiness of dryer i.e. compressed air dew point temp. is within working limit so that no wet air carried to our end unit.

In addition to general Preventive /Breakdown visit bidder should ensure 2 No's of OEM visit to resolve all the critical issue related to performance of compressor as per SPM requirement.

Terms of visit:

- 8 preventive Visit,4 Breakdown,2 OEM service engineer visit & 2 visit for Dryer of both screw air compressor will be covered in one year during service plan. The above can be plan as per SPM convenience except Public holiday. However SPM intimate date of visit in advance so that it can be plan accordingly.

Firm should provide list of all consumable & non consumable spare after awarding of contract which is used during maintenance of a compressor. Also intimate emergency spare before the visit(if any)

- The work is to be carried out under the supervision of SPM Authorized Representative
- All Tools and tackles and testing instruments etc. & necessary manpower for moving & lifting of heavy parts required for Preventive and breakdown/Corrective maintenance, shall be provided by SPM.
- Transport : No separate charges will be paid for transport, Lodging & boarding. It shall be provided free of cost by the contractor.
