1. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Generic

End User Certificate: Wherever Bidders are insisting for End User Certificate from the Buyer, same shall be provided in Buyer's standard format only.

4. Purchase Preference (Centre)

Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. 1. Air Conditioning:

Supply, installation and commissioning of 85 Tons. capacity Cassette air conditioners/ Duct type air conditioning including all accessories/fitting like indoors/outdoors stands, Copper pipings, suitable electrical cables from the PDB and drain water pipes for the A.C, all civil works like chiseling/drilling/grouting and bolting etc. included)

Make: DAIKIN/VOLTAS/BLUE STAR/HITACHI or equivalent. etc. complete on turnkey basis

Area to be covered # 18.91 Mtrs. X 40.91 Mtrs. = 766.04 Mtrs.

2. False ceiling & light 2 x 2 panel:

Supply and installation of Armstrong ceiling 2x2 with supporting frame complete. Supply, installation, Testing and commissioning of Necessary Electrical lighting panels, Electrical panels for Air conditioning, electrical cable from substation to air conditioning electrical panels, earth pits and other electrical work at site as per the requirement.

- b. 2 X 2 Panel 36 W with sufficient light 70 panels

3. Power Cable from sub-station to Blank store:

- The indoor units shall be uniformly distributed in the shop floors.
- The outdoor units shall be kept outside of blank store and all the quantities of pipes cables etc., are to be taken accordingly.
- The lighting fixers shall be of 2 ft X 2 ft panels each having 36 Watt capacity to suit false ceiling and the number of lights shall be 70 Nos and as per existing IS standards.

- All the door openings shall be with suitable air curtains/ Falls.
- Supply of Required number of CASSETTE type indoor units (Round flow Cassette Units) comprising with pre-filter, fan section with low noise fan multi speed moto, coil section with DX coil, outer cabinet, drain water lift-up mechanism, insulation, pipe connections, fresh air intake etc. of various capacities. WITH CORDLESS REMOTE CONTROLLER.
- Supply & installation of suction & discharge hard copper Refrigerant piping with proper supports/hangers from ceiling /wall as required at site & approved by mint/ consultant & duly insulated with closed cell elastomeric nitrile insulation.
- Supply and Erection of PVC hard condensate drain piping with thick Nitrile insulation including support and wall opening.
- Supply and Laying of Control cable lying connecting the IDUs and ODUs (control wiring using 2C x 1.5 Sq. mm copper cable) with conduit.
- Supply and Laying of Remote cabling between each IDU & its wired remote sensor to be suitably laid in PVC conduit as per site requirement.
- Supply and installation of Armstrong ceiling with supporting frame complete. - Vacuuming the system, Gas topping up of suitable refrigerant, pressure testing and commissioning of above lot.
- Testing and Commissioning: The Contractor must perform and confirm all inspection and tests of the system as a whole and of components individually as required and to furnish necessary test certificates from the manufacturers.

The system shall be tested and balanced continuously round the clock for 21 hours each day for 3 consecutive days to fulfill the intent and purpose for which it is designed at 22 +/- 2 degree Celcius - Trench to be filled and made as earlier as per CPWD norms and markers to be installed.

GENERAL TERMS AND CONDITIONS:

- All materials shall be of quality confirming to reputed make & specifications matching with relevant IS standards.
- Technical Documentation.
- Supporting technical brochures / literatures / catalogues indicating each feature in respect of offered model and make must be submitted along with the offer. The technical brochures / literatures / catalogues submitted by the supplier should satisfy the technical criteria for which the supplier has indicated his compliance in response to the bid. Successful bidder shall submit 3 sets of layout, technical drawings, electrical wiring drawings and operating & maintenance manuals.
- All unloading of the material, shifting, positioning & Installation of Outdoor and Indoor units (cassette type) shall be contracted firm's responsibility.

The tenderer is to provide the required details, information, confirmations, etc. accordingly, failing which it is tender is liable to be ignored. Prospective bidders shall comply with the feature specifications (including Warrantee Obligations) and submit a "Specification Compliance Certificate" with their Technical Bid.

2. Quality control requirements

The services provided by the successful bidder will be inspected as per the parameters mentioned in Section VII: Technical specification of tender document. In case the Services is found not meeting the specification, the purchaser shall be entitled to cancel the contract, and if so desired, purchase or otherwise the purchase of the services at the risk and cost of the contractor

3. Qualification/Eligibility Criteria

(a) Experience & Past Performance (Exempted for MSEs firms)

The bidder should have experience of having successfully completed similar works during last 7 years ending on 31.03.2021

a. Three similar completed works each costing not less than the amount equal to Rs.21.73 Lakh

or

b. Two similar completed works each costing not less than the amount equal to Rs.27.16 Lakh

or

c. One similar completed work costing not less than the amount equal to Rs.43.46 Lakh

(b) Capability - Equipment & manufacturing Facilities:

The bidder should be enlisted in either Central Public Works Department (CPWD) or Military Engineering Services (MES) or any other Government /PSU / Autonomous bodies

(c) Financial Standing:

(1) The average annual financial turnover of the bidder during the last three years, ending on 31.03.2021, should be at least Rs.21.73 lakh as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/ Cost Accountant in India.. (Exempted for MSEs firms)

(2) The bidder should not have suffered any financial loss for more than one year during the last three years, ending on 31.03.2021.

(3) i) The net worth of the Bidder should not be negative on 31.03.2021 and alsoii) should not have eroded by more than 30% in the last three years, ending on 31.03.2021.

All experience, past performance and capacity /capability related / date should be certified by the authorized signatory of the bidder firm. The credentials regarding experience and past performance to the extent required as per eligibility criteria submitted by bidder may be verified from the parties for whom work has been done.

All financial standing data should be certified by certified accountant's e.g. Chartered Accountants (CA). Bidder to furnish stipulated documents in support of fulfillment of qualifying criteria.

Non-submission or incomplete submission of documents may lead to rejection of offer.

3. Performance Bond/ Security:

The successful bidder shall furnish Security Deposit within 21 days of issue purchase order in the form of unconditional Bank Guarantee/ Account Payee Demand Draft, from any scheduled commercial Bank of India in favour of the "India Government Mint, Noida", for 3% value of the purchase order valid upto 60 days beyond the date of completion of all contractual obligations by the supplier, including the warranty obligations. Further, if bidder fails to furnish the required performance security within the specified period, he shall be liable to face suspension from participating in Tenders invited by any of the unit of SPMCIL for a period of one year from the time of such suspension.

4. Warranty Clause

12 months from the date of final acceptance certificate, in case of any claim, the firm has to attend the same within 24 hours of complain and settled the same within 2 days.

5. Taxes and Duties

Supplier shall be entirely responsible for all taxes, duties, fees, levies etc. incurred until delivery of the contracted goods to SPMCIL. If the tenderer fails to include taxes and duties as per law of the land in the tender, no claim thereof will be considered by purchaser at a later stage.

6. Terms and Mode of payments

100% Payment will be released within 30 days after successful completion of job work and due certification report from the user section. GST as applicable as per rules. TDS, if applicable will be deducted from the firm's bill & subject to submission of bill in triplicate as well as all required documents by the supplier.

7. Quantum of LD

If successful supplier fails to deliver the item within the time frame(s) incorporated in the contract, IGMN shall, without prejudice to other rights and remedies available to IGMN under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the 0.5% of the delivered price of the delayed goods for each week of delay or part thereof until actual delivery, subject to a maximum deduction of the 10% of the delayed 'goods' contract price(s).

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specification and / or terms and conditions governing the bid. Any clause incorporated by the Buyer such as demanding Tender Sample, incorporating any clause against the MSME policy and Preference to make in India Policy, mandating any Brand names or Foreign Certification, changing the default time period for Acceptance of material or payment timeline governed by OM of Department of Expenditure shall be null and void and would not be considered part of bid.
