In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for

exemption must be uploaded for evaluation by the buyer.

- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria". If the bidder is OEM of the offered products, it would also be exempted from the "OEM Average Turnover" criteria. - 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and Small enterprises will be allowed to participate. In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
- 7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.
- 8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 9. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Buyer Added Bid Specific Terms and Conditions

1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- I. SPECIAL CONDITIONS OF CONTRACT (SCC)
- 1) **Country of Origin:** The country of origin of the goods/ machine shall be clearly mentioned.
- 2) Pre-Despatch inspection:
- a) The 11KV PDB panel will be subjected to pre-dispatch inspection at firm's works by three ISP officials prior to its delivery at ISP unless inspection is waived by ISP.
- b) The cost towards the deputation of ISP officials for PDI will be borne by ISP.
- c) At the time of PDI, the panels shall be completely assembled, wired and ready for operational testing under full load conditions to ensure correctness of its functions. The panels shall be tested for acceptance/routine tests as specified in the relevant latest Indian Standards. Completely assembled panel shall be tested for its temperature rise with the simulated conditions.
- 3) Transportation of Goods: The transportation of goods to be procured will be done by the supplier on

FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item to be procured.

- 4) **Insurance:** Specific insurance cover for each consignment / supply is to be given by firm, as applicable.
- 5) **Distribution of Despatch Documents for Clearance/ Receipt of Goods** The supplier shall send all the relevant despatch documents well in time to ISP Nashik to enable ISP Nashik to clear or receive (as the case may be) the goods in terms of the contract.

6) Warranty Clause:

- a) The equipments supplied & installed under this contract shall be warranted against any type of defects arising due to design, fault, material, workmanship, poor packing and damage during transportation and unloading/shifting/lifting, storage and for trouble free operation.
- b) The Warranty shall remain valid for a period of minimum one year from the date of final acceptance certificate issued by ISP and shall include repairing and replacing of defective parts of the system, required operational and maintenance support services at free cost, which are essentially required to put the entire system in normal operation.
- c) The firm will have to give warranty that the goods supplied under this contract are new, of the recent models and incorporate all recent improvements in design and materials unless provided otherwise in the contract.
- 7) **Taxes and Duties**: If the tenderer fails to include taxes and duties in the tender, no claim thereof will be considered by purchaser at a later stage.
- 8) **Terms and Mode of Payment:** 100% payment of the work will be made on successful supply, installation, testing, commissioning, training and acceptance by the consignee. The payment will be done through online mode only. Therefore, the suppliers have to produce all the Bank details such as Name of Bank, Account No., IFSC Code No., MICR No. along with the Tender document. TDS, if any, will be deducted on installation, testing, commissioning and training work.
 - **II. REQUIRED DELIVERY SCHEDULE:** Within 06 months from the date of Purchase Order/Letter of Intent issued by ISP.

III. QUALITY CONTROL REQUIREMENTS:

- A) Final Acceptance Test
- a) The supplied and installed VCB Panel including all accessories ,material and its workmanship will be checked and tested at "No load" and "On Load" as per ISP's Purchase Order specifications.
- b) The performance Tests shall be carried out by the successful bidder for 4 Days, of entire VCB panel, its components supplied and installed, for all operational, protection & safety interlocks, in presence of ISP representatives, as per ISP's Purchase Order specifications.
- c) Any short falls or any problems encountered during the F.A.T period will have to be repaired and corrected immediately without any cost to ISP and ensure no adverse impact on ISP's Installation and MSEDCL supply source.
- B) Final Acceptance Certificate (FAC): After successful completion of FAT, FAC will be issued.

IV. QUALIFICATION/ELIGIBILITY CRITERIA:

- (1) Minimum Eligibility Criteria:
- (a). Experience: The Bidder (manufacturer or principal of authorised representative) shall be a manufacturer that has regularly for at least the last three years manufactured, supplied, erected,

commissioned VCB Panel board of rating: >/= 11 KV and individual VCB of current capacity: >/= 630 ampere, during last five years ending on 31st March 2021. At least one number of the product offered for supply should be in successful operation for at least one year on the date of bid opening.

Note: Start-ups and Micro and small Enterprises are exempted from Experience and Past Performance criteria. In case any bidder is seeking exemption from Experience and Past Performance criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.

(b). Capability, equipment and manufacturing facilities:-

The bidder must have an should annual capacity to manufacture and supply at least one VCB Panel Board with 5 VCB's of rating: >/= 11 KV and individual VCB of current capacity: >/= 630 ampere.

(c). Financial Standing:

(i) Average Annual Turnover of the bidder firm (manufacturer or principal of authorised dealer) during the last three years, ending on 31.03.2021, should be at least Rs. 26,75,042/- as per the annual report (audited balance sheet and profit & loss account) of the relevant period duly authenticated by a Chartered Accountant/Cost Accountant in India.

Note: The Average Annual Turnover criteria are exempted for Start-ups and Micro and Small Enterprises. In case any bidder is seeking exemption from Average Turnover criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.

- (ii) The bidder should not have suffered any financial loss for more than one year during the last three years, ending on 31.03.2021.
- (iii) The net worth of the bidder should not be negative and also not have eroded by more than 30% in the last three years, ending on 31.03.2021.

Note: The criteria for Capability, Equipment and Manufacturing facilities as well as financial loss and net worth under the financial standing eligibility criteria (above) shall be applicable to all the bidder firms including MSEs & Startup Firms.

(2) Other Requirements:

- a) PAN: The Bidder should be registered with the Income tax. Relevant proof in support shall be submitted.
- **b) Goods & Services Tax Registration: -** The Bidder should be registered with the Goods & Services Tax Department. The bidder firm should submit GST Registration Certificate. Relevant proof in support shall be submitted.
- c) Manufacturer's authorization: The interested bidder must be either Original Equipment Manufacturer (OEM) or authorized dealer of the OEM, with the valid authorization certificate issued in their own name from the OEM. The self attested copy of such valid authorization from OEM shall be submitted along with the bid with an undertaking from the OEM that they will provide after Sales Services for the next 10 Years in case the bidder firm fails to do so.
- **d) Valid Electrical Contractor Licence:** The interested bidder must be holding valid electrical contractors license issued by the Competent Authorities of State/Central Govt. and a self attested copy of the same shall be enclosed along with the bid.

(3) Undertaking(s) on firm's letter head:-

- (a) The firm should give undertaking that, "We have not been black-listed/ debarred for dealing with any Govt. Organization / Public Sector Undertaking (PSU) / Reputed Organization in the past".
- (b) That "the information given in the documents are correct and the Bidder is awared that in case any information provided is found to be false at a later stage, ISP reserves the right to reject/ disqualify the bidder at any stage of the tendering process without assigning any reason."
- (c) The firm should give undertaking that, "We agree to withdraw all the deviations, if any, unconditionally and accept all the terms and conditions of the tender document including the technical specifications".
- (d) The firm will have to give an undertaking that they will provide after sales support which includes supply of spares and consumables for next 10 years, on site and off site warranties of various equipments and system installed.
