1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria". Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 6. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.

7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

## **A. MINIMUM QUALIFICATION CRITERIA**

**1. Experience:** The bidder (manufacturer or principal of authorised representative) should have manufactured and supplied ABB PLC along with recovery and loading of machine programme of at least 03 Nos. in any one year during last five years ending on 31.03.2021 i.e. from 01st April 2016 to 31st March 2021.

Note: Start-ups and Micro and small Enterprises are exempted from Experience and Past Performance criteria. In case any bidder is seeking exemption from Experience and Past Performance criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.

### 2. Capability, equipment and manufacturing facilities:-

The Bidder must have an annual capacity to manufacture and supply at least 03 nos. of similar PLC along with recovery and loading of machine programme.

### **3. Financial Standing:**

(i) Average Annual Turnover of the bidder during the last three years, ending on 31.03.2021, should be at least Rs. 8,98,038.40 as per the annual report (audited balance sheet and profit & loss account) of the Financial Year 2018-2019, 2019-2020 & 2020-2021, duly authenticated by a Chartered Accountant/Cost Accountant.

(b) Installation, Testing and programming: - The firm must have to program the PLC without affecting existing machine software and program and give on load trial for 7 production days.

Terms and conditions of supply:-

1. The said work is for supply, loading of ISP's machine software programme and successful On load trials of supplied PLC's on ISP's machines complete as per given specifications, only supply will not be acceptable.

2. The firm will have to confirm in writing that, offered PLC complete with machine programming IC, machine programme and software versions are as per given specifications and suitable for direct replacement without any modifications as regards to machine software requirement, all Input, Output terminals, including their identification numbers ,Communication port, mounting arrangement etc. on our printing machine.

3.ISP does not have the copy of programme and the firm will have to copy the same from existing running PLC's, if required by necessary password unlocking of PLC programme/machine programme from main consoles HDD having OS2 as Operating software and KBA's machine programme is also included in the scope. The firm will have give an undertaking in writing, that in case of problem to the existing machines software during copying or reverse engineering, they undertake to replace the existing software within 3 days without any cost to ISP.

4. The firm will have to give 01 years onsite warranty of the supplied material and workmanship.

5.Bidders offering PLC other than ABB make and type will have to confirm in writing that offered PLC are exactly of same type for direct replacement without any modifications, in respect of dimensions due to space constraints and channel mounting arrangement, contact configuration i.e. I/O arrangement, plug in connectivity and wiring position of PLC module to ensure sanctity of the existing control wiring and software and our requirement of instant interchange ability in case of need. Any modifications and alterations in dimension, contact configuration and wiring will not be accepted.

6.The firm shall send the detail product brochure along with exact model offered, programming IC version etc. for our reference along with the bid.

7.As the existing machines are having heavy production load, the firm will be given shut down as per ISP's production schedule and will have to complete the said work within minimum time without hampering ISP's production.

8. The firm will have to confirm in writing that they will provide 10 years after sales support after supply of material.

9. The firm and their team of manpower will have to follow all the Safety and Security regulations of ISP's Safety Department and CISF. The firm's engineers & representatives will have to submit the copy of PVR for the entry permission at ISP.

10. The firm will have to carry out the works on ISP's working Days from 8.00am to 4.30 PM.

## C. Special Conditions of Contract (SCC)

### (To be submitted on firm's Letter Head as a token of acceptance)

**1) Transportation of Goods:** The transportation of goods to be procured will be done by the supplier on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item to be procured.

**2) Insurance:** Since Indigenous bidder has to deliver the material on FOR ISP Nashik basis therefore the cost of the insurance will also the part of the cost of the material borne by the supplier. A specific insurance cover for each consignment/supply is to be given by firm, as applicable.

**3) Distribution of Dispatch Documents for Clearance/Receipt of Goods:** The supplier shall send all the relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik to clear or receive (as the case may be) the goods in terms of the contract.

**4) Warranty Clause:** Warranty will be applicable for 01 (one) year on offered material and workmanship from the date of acceptance of goods by the Purchaser.

**5) Taxes and Duties:** Supplier shall be entirely responsible for all taxes, duties, fees, levies etc. incurred until delivery of the contracted goods to SPMCIL. If the tenderer fails to include taxes and duties as per law of the land in the tender, no claim thereof will be considered by purchaser at a later stage.

**6) Terms and Mode of Payment:** 100% payment will be done within 30 days after receipt and acceptance of goods by the Purchaser and on production of all required documents by the supplier. The payment will be done through online mode only. The suppliers should have to submit the e-invoice for payment purpose. Also, the supplier should have to produce all the bank details such as Name of Bank, Account No., IFSC Code No., MICR No. along with the Tender document.

Bidders can also submit the EMD with Account Payee Demand Draft in favour of India Security Press, A unit of SPMCIL payable at Nashik.

Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

## 3. Forms of EMD and PBG

## 7. Warranty

The seller should guarantee the rectification of goods in case of any break down during the guarantee period. # Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity/restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and/or terms and conditions governing the bid. Any clause incorporated by the Buyer such as demanding Tender Sample, incorporating any clause against the MSME policy and Preference to make in India Policy, mandating any Brand names or Foreign Certification, changing the default time period for Acceptance of material or payment timeline governed by OM of Department of Expenditure shall be null and void and would not be considered part of bid.
