1. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

2. Forms of EMD and PBG

Bidders can also submit the EMD with Account Payee Demand Draft in favour of Security Printing Press, Hyderabad payable at Security Printing Press, Hyderabad.
Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

3. Forms of EMD and PBG

Bidders can also submit the EMD with Fixed Deposit Receipt made out or pledged in the name of A/C (Name of the Buyer). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of EMD, the FDR will be released in the favour of the bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Bidder has to upload scanned copy/ proof of the FDR along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/ Bid Opening date

4. Forms of EMD and PBG

Bidders can also submit the EMD with Banker's Cheque in favour of Security Printing Press, Hyderabad payable at Security Printing Press, Hyderabad.
Bidder has to upload scanned copy / proof of the BC along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

5. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. OPTION CLAUSE: The Purchaser reserves the right to increase the ordered quantity(period of contract) by 25% at any time, till final delivery date of the contract even though the quantity ordered initially has been supplied in full before the last date of Delivery Period.

2. The bidder should submit the additional Performance Security for Option Clause and also should submit extended Performance Security of the Original Contract valid up to 60 days beyond Contractual Obligations..

3. The bidder has to submit their PAN card, GST Certificate, Complete Bank details and Firm's complete contact details.

4. Experience and Past Performance: The bidder should have experience of having successfully supplied at least 2 persons of similar manpower services in any one of the last five years ending 31.03.2021.

5. Capability: The bidder must have capability to provide the relevant similar services.

6. Financial Standing:

6.1 The average annual financial turnover of the bidder during the last three years, ending on 31.03.2021 should be at least Rs. 6lakhs as per the annual report (audited balance sheet and profit & loss account)

of the relevant period, duly authenticated by a Chartered Accountant/ Cost Accountant in India or equivalent in relevant countries.

6.2 The bidder should not have suffered any financial loss for more than one year during the last three years ending on 31.03.2021

i) The net worth of the bidder should not be negative on 31.03.2021 and also ii) should not have eroded by more than 30% in the last three years, ending on 31.03.2021.

7. Non Blacklist Declaration: The firm should not have been blacklisted/ debarred for dealing by Government of India/ State Government/ PSU/ SPMCIL/ RBI/ BRBNMPL/ BNPMIPL in any manner and an undertaking should be submitted along with the bid to this effect.

8. Service provider/bidder must submit the registration documents from EPF and ESIC at the time of submission of GeM tender document.

9. After issue of LOI/Notification of award of contract/Contract Order to bidder, the bidder shall provide at least three CV's within seven days for each position to SPPH and deployment to be done within 15days after clearing the interview.

10. The bidder has to submit police verification certificate of deployed manpower.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity/restriction arising in the

bidding process due to these ATCs and due to modification of technical specifications and/or terms and conditions governing the bid. Any clause incorporated by the Buyer such as demanding Tender Sample, incorporating any clause against the MSME policy and Preference to make in India Policy, mandating any Brand names or Foreign Certification, changing the default time period for Acceptance of material or payment timeline governed by OM of Department of Expenditure shall be null and void and would not be considered part of bid. Further any reference of conditions published on any external site or reference to external documents/clauses shall also be null and void.
