1. Design, Supply, Installation, Testing and Commissioning of 2-Hi 14" Cold Rolling Mill.

Technical Specifications:

A. Type: 2-Hi with Reversible motion of rollers (clock wise & anti clockwise).

B. Foundation job: Dimension of the Machine and Foundation Bolts along with necessary drawings to be supplied by the party with detailed lay out of Civil foundation works before installation of machine. The party may supervise the civil work for the foundation of the mill.

C. Diameter of Rolls: 14 inch (apprx. 355 mm)

D. Length of the Rolls: 11 inch (apprx. 275 mm) excluding the journal.

E. Hardness of Rolls: 63 to 64 HRC.

F. Roll material: D3 alloy steel.

G. Input material: Cupro-Nickel (75% Cu and 25% Ni), Tombac-Bronze (92%Cu, 6% Zn and 2% Ni), Silver and Gold with different finesse.

H. Dimension of material:

- a. Input : 110mm(width) X 15mm(thickness) X 1200-1800 mm (Length)
- b. Output: 110mm (width) X 4mm (thickness) +/- 0.020 mm

I. Screw down operation: Manual with minimum rate of Step down is 0.01mm along with suitable gear assembly.

J. Speed of Roll: Variable speed from 0-30 MPM with AC variable frequency drive.

K. Lubrication: Centralized oil circulation/lubrication system for all movable parts i.e. gears, shafts etc. of the mill must be provided with proper nomenclature and grade of the lubricant.

L. Cooling system: Internal and external cooling of rolls must be provided with suitable means along with coolant collection tank. The coolant should be non-staining type. Nomenclature and grade of coolant must be provided by the party.

M. Structure: Heavy duty Mild Steel (i.e. IS 226 or equivalent) suitable for rolling operation.
