

Subject: **Review of mechanism to ensure probity among Government servants.**

The undersigned is directed to say that a Committee of Secretaries (CoS) in its meeting on 01.11.2018 at Cabinet Secretariat, reviewed the progress made by the Cadre Controlling Authorities/Ministries/Departments on the subject of review of mechanism to ensure probity among Government servants.

2. During the aforementioned meeting, the CoS deliberated and recommended as follows:

- (i) Ministries/Departments may ensure that special exercise is undertaken to complete the review of cases under FR 56(j) and similar provisions.
- (ii) Ministries/Departments may review and take action in respect of pending Disciplinary Proceedings and sensitive posts occupied by personnel beyond 03 years. Similar action may be taken in respect of various organisations under the Ministries/Departments. Rotational Transfer Policy may be implemented by all Cadre Controlling Authorities (CCAs).
- (iii) Ministries/Departments may ensure strict compliance of the timelines provided for completion of disciplinary proceedings.
- (iv) Respective CCAs for All India Services officers may ensure that the review of officers is done by all the States and report is submitted timely.
- (v) Pending Prosecution Sanctions may be disposed of expeditiously by all Ministries/Departments as per the amended provisions of Prevention of Corruption Act, 1988.

All the Ministries/Departments are advised to ensure wide circulation and active compliance of the CoS recommendations stated in para 2 of this OM.
