





ISP Nashik will respond in writing to such request provided the same is received by ISP Nashik not later than 21 days prior to the prescribed date of submission of tender.
- SIT 3: Earnest Money Deposit (EMD): Exempted. However, Bidder is requested to submit the duly stamped and Signed Annexure-I (Enclosed at the end of this Tender Document).

SIT 4: Tender Validity:-

- (i) The tenders shall remain valid for acceptance for a period of **120 days after the date of tender opening** prescribed in the tender document. Any tender valid for a shorter period shall be treated as unresponsive and rejected.
- (ii) In exceptional cases, the tenderers may be requested by ISP Nashik to extend the validity of their tender upto a specified period. Such request(s) and response thereto shall be conveyed by surface mail or by fax/ e-mail followed by surface mail. The tenderers who agree to extend the tender validity, are to extend the same without any change or modification of their original tender.
- (iii) In case the day upto which the tenders are to remain valid falls on/ subsequently declared a holiday or closed day for ISP Nashik, the tender validity should automatically be extended upto the next working day.
- (iv) Compliance with the Clauses of this Tender Document: Tenderer must comply with all the clauses of this Tender Document. In case there are any deviations, these should be listed in a chart form without any ambiguity along with justification.

- SIT 6: Submission of tender: <u>Techno Commercial Bid</u> and <u>the Price Bid</u> are to be submitted in Two Separate double sealed Envelopes on or before the due date of the submission of the tender as stated below otherwise tender/bid/quotation shall be liable for rejection.

PART I: Techno-Commercial bid :- (First Envelope):

- Earnest Money Deposit: Exempted. However, Bidders are requested to submit the Duly Stamped and Signed Annexure-1 (Enclosed at the end of Tender Documents). the attached Annexure-1 shall be treated as part of this Tender Documents. Annexure-1 of this Tender Document is to be printed on Bidder's Letter Head.
- **2. Power of Attorney/ Authorization** with the seal of company indicting that authorized signatory is competent and legally authorized to submit the tender and/ or to enter into legally binding contract.
- 3. The eligibility criteria for the tender are given in Section IX- Qualification/ Eligibility Criteria. The bidder has to submit all the desired documents and relevant documentary proof in support of relevant clauses mentioned in Section IX: Qualification/ Eligibility Criteria. The Qualifying Criteria should be submitted in original.

- i. Each envelope containing bids shall be super scribed as, <u>Techno-commercial Bid</u> and <u>Price Bid</u> separately as the case may be for "HIRING OF PRIVATE VEHICLES/TAXI ON RATE CONTRACT BASIS". SIT 7: Opening of Tender & Evaluation Process:

- 7.1 In the first instance, the **Techno-Commercial** part of Tender document will be opened and considered for the evaluation. These offers/ bid will be scrutinized and evaluated by the competent committee/ authority with reference to the parameters prescribed in the eligibility criteria (**Section IX**). The technical acceptance of the bids is on the basis of **Technical Specifications** offered by the bidders as per **Section -VII** Technical Specification and Section-VI List of Requirement of the tender document and acceptance of the terms and conditions as per GIT, SIT, GCC, SCC, other conditions of tender. **Conditional offers will be liable for rejection.**
- 7.2 In the second stage, the Price Bid of only Techno Commercially Qualified firm offers (as mentioned first stage) will be opened for further scrutiny and evaluation.
 - The intimation regarding opening of price bids shall be given to qualified tenderers to enable them to attend the technical and price bid opening, if they so desire.
- 7.3 **Price bid evaluation:** In the second stage, the price bid of only the technically suitable offers will be opened for further scrutiny and evaluation. The Individual L-1 bidder will be decided based on the total financial implication calculated to ISP, Nasik considering all the taxes, duties etc.
 - i) The evaluation of L-1 for Schedule A and B will be done for each type of vehicles separately i.e. for each Column (Column 3, 4, 5 and 6), a separate L-1 bidder will be there. A bidder can become L-1 for more than one such column depending upon their quote.
 - *Formula for deciding L-1 for schedule A and B= (Rate of Sr. No. "A" + Rate of Sr. No. "B(ii)")
 - ii) The evaluation of L-1 for Schedule C, D, E and F will be done for each Vehicle (Column no. 3, 4, 5 and 6), a separate L-1 bidder will be there. A bidder can become L-1 for more than one such Vehicle in respect of each Schedule, depending upon their quote.

SCC-1: Performance Bond/ Security:

- (i) If value of contract is more than 2.5 lakhs the successful bidder has to submit Performance Bond/ Security equivalent to 3% of the order(s) value, valid for a period of 60 days beyond the completion of all contractual obligations by the supplier, including the warranty period, within 21 days from the date of issue of Letter of Intent/award of contract.
- (ii) The Performance security shall be denominated in Indian Rupees or in the currency of the contract and shall be in one of the following forms:
 - a) Account Payee Demand Draft or Fixed Deposit Receipt drawn on any commercial bank in India, in favour of ISP, unit of SPMCIL payable at Nashik.
 - b) Bank Guarantee issued by a commercial bank in India, in the prescribed form as provided in section XV of this document.
- SCC 2:- Distribution of Dispatch Documents for Clearance/Receipt of Services: The service provider shall send all the relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik to clear or receive (as the case may be) the service in terms of the contract.



- **SCC 4:- Option Clause:** The purchaser reserve the right to increase the ordered quantity by 25% in terms of period & value at any time, till final delivery date of the contract, by giving reasonable notice even though the quantity ordered initially has been supplied in full before the last date of the delivery period.
- SCC 5:- Taxes and Duties:- Supplier shall be entirely responsible for all taxes, duties, fees, levies etc. incurred until delivery of the contracted goods/Services to SPMCIL. If the tenderer fails to include taxes and duties as per law of the land in the tender, no claim thereof will be considered by purchaser at a later stage.

SCC 6:- Terms and Mode of payments:-

- A) The payment to the Contractor shall be released on monthly basis at actual usage as per applicable price.
- B} Payment for service rendered under Sch. No. A and B:- The Payment will be released as per applicable price of Sch. No. 'A' of price bid for respective services and on actual Km. Basis as per Km. charges prescribed in Sch. No. 'B' of Section XI.
- C) Payment for service rendered under Sch. No. C, D, E and F:- The Payment will be released as per applicable price prescribed in each schedule of Section XI.
- C} GST applicable as per rules.
- D} The TDS, if any, will be deducted.
