1	<p><b>TECHNICAL SPECIFICATIONS OF BLOCK BOARD BOXES</b></p> <p>i. Internal size of Common type Box 680 mm L x 600 mm W x 310 mm H. ii. The packing cases of size as mentioned above shall be made out of block board conforming to IS 1659:1990 revised to 1659:2004 RA-2004 interior grade of uniform thickness 19 mm. iii. Box shall be made of 6 pieces and none of the six block board pieces used for the assembly of the boxes should have any joints on the surface as the boxes will be used for packing the currency notes. iv. Boxes should be supplied as per the drawing enclosed in tender. v. Five layered block board of well-seasoned good quality wood shall be used consisting of top bottom face veneers of 0.5 to 0.6 mm thick and top bottom core veneers of 1.8 to 2.0 mm thick. vi. The center core battens of the block board should be softwood or medium density wood with minimum 14 mm 0.5 mm thickness, width of 30 mm 1 mm and 300 mm length joined together in staggered formation. vii. All layers should be well seasoned well bonded with BWRMR grade adhesive conforming to IS 848:1974. There should not be any gap between the battens used in the block board. viii. Nails of size 65 mm x 12 SWG with washers should be used for assembling the boxes. ix. The ends of top bottom sides of the boards should remain slightly elevated as shown in the assembled view of the drawing, so that the top bottom lids can be flushed in side to make the level remain uniform all the sides. x. sufficient mechanical strength shall be able to carry and withstand product weight of 125 Kilogram under jerks rough handling during loading and unloading in Treasury van. These will be stacked three high one over the other in the treasury. xi. The nailed strapped box should not get opened or de-shaped while dropping from a height 7 feet with load of 125 Kilogram. The supplied boxes would be tested randomly. TERMS CONDITIONS

- 1 The box should be delivered in complete assembled condition leaving the top lid open. CNP will not provide any spaceshed inside the factory supplier has to arrange work place locally outside CNP for assembling the boxes in case they are transported in loose condition from manufacturing place to CNP Nashik at his own cost.
- 2 The supplier must enclose certificate from a Govt. approved laboratory that the block board used for making the boxes is conforming to IS 1659:1990 revised to 1659:2004 RA2004 interior grade, along with pilot sample, failing which payment will not be released and if required CNP reserves the right to ask the firm to send other lots to be checked from Govt. approved labs.
- 3 The boxes should be neat, clean uniform in dimension as per specification. The block boards supplied shall be inspected and randomly checked and in the event of block boards found not conforming to specifications and terms conditions, the entire lot will be rejected. The rejected lot will be removed from CNP by the supplier at his own cost within 30

days failing which CNP will take action to remove the material at risk cost of supplier. 4 Inspection will be carried out at Currency Note Press, Nashik. In the event of rejection of supplied lot, if the firm desires to have joint inspection at CNP, then the said request should be sent within 20 days of the issue of intimation by rejection note sent. After that, no claim whatsoever shall be entertained. 5 The supplier will be responsible for obtaining clearance permission or complete formalities required to be completed with the concerned state government or any other department for the supply of boxes to CNP Nashik. CNP will not be responsible for any litigation in this respect. 6 The boxes supplied must have sufficient strength and will not de-shape while dropping from a height of 7 feet with a load of 125 Kg material. 7 The firm shall furnish self-certificate that the supplied block board boxes have been given anti-termite treatment. 8 Boxes to be marked with company Logo and Name To be provided to successful bidder. 9 Boxes to be marked with month and year of manufacturing.
