- 1) Maximum number of employees will be examined for above parameters.
- 2) Minimum 20 employees must be examined in one working day.
- 3) No examination shall be conducted on Sundays and Holidays.
- 4) All type of consumables i.e. Medicines, X-ray Films, Cotton; Syringes etc. shall be brought by the Certifying Surgeon for conducting the Medical Examination.
- 5) The examination fee will be released on the basis of number of employees actually examined by the Certifying Surgeon and proper certificate is issued for each employee by certifying surgeon.(Form No.07).

- 10) To sublet or to transfer the contract in part or in whole shall be treated, as breach of contract and it shall be punishable by forfeiting the Security Deport or termination of Contract. Regd.



Section VIII : Quality Control Requirements

1. The support staff appointed by certifying surgeon for carrying out medical examination should be experienced enough to carry out the required test. Trainee or apprentice candidate should not be appointed to carry out ECG, Blood test & X Rays. which might lead to physical or bodily injury to employee or variation in accuracy.
2. The X-Ray m/c should be approved by competent authority/regulatory body.
3. Electrical equipment's should be calibrated, if required.
