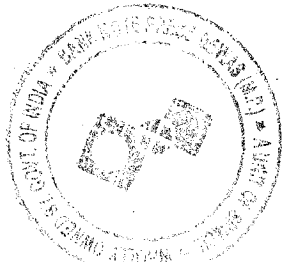
Sir,
