- 8. Payment of GST is primarily the responsibility of the seller and will not be paid unless the percentage value is clearly mentioned in the quotations. If no indication regarding GST is recorded in the quotation, the GST will be considered as included.
- 9. Delivery Period required for supplying the material should be invariably specified in the quotation.
- 10. In case your quotation is accepted, and order is placed on you, the supply against the order should be made within the period stipulated in the order. Purchaser reserves the right to recover any Loss sustained due to delayed delivery by way of penalty. Failure to supply the material within the stipulated period shall entitle the Purchaser for imposition of Penalty without assigning any reasons @ 1/2% of the total value of the item covered in order as Penalty per day subject to a maximum of 5% unless extension is obtained in writing from the office on valid ground before expiry of delivery period.

#### **ANNEXURE - I**

# Scope of work:

- A. Two visits at an interval of six months by one Engineer for three days in each visit.
- B. General Physical & Functional examination of external and internal parts of instruments.
- C. Cleaning, Lubrication and Overhauling of instruments.
- D. Identification & replacement of defective, broken & worn out parts of instruments.
- E. Calibration of each instrument and issue the Calibration Certificate valid for 6 months or one year, Traceable to National / International Standards.
- F. Service report of instruments comprising general condition of the instruments.

# General Term and condition:

- 1. Calibration of instrument after servicing and the firm shall provide necessary technical support during the period of AMC.
- 2. One free breakdown maintenance should be provided as and when if required during the AMC period.
- 3. Calibration of instruments should be undertaken as recommended by instrument manufacturer in accordance to the relevant Testing Standards.
- 4. Pre-calibrated Tools and Equipments which have been used for service must be certified by IGT/ standard testing laboratories (Traceable to National/International Standards)
- 5. If there is any break down while doing the service work, the service engineer should provide the list of required spare parts which will be made available. However, till such period the instrument may be set right if possible.
- 6. A Report of Service should be provided for each instrument with the following information:
- a) General condition of the instrument
- b) Calibration parameters
- c) Requirement for replacement of worn, defective, damaged spares.
- 7. During checkup of the instrument/system, if any minor wear and tear is noticed, then the EHI service engineer should try to set the system in working order.
- 8. Defective instruments should be inspected and the problems may be diagnosed to the extent possible and recommendation on the spares to be replaced should be given if such spare parts are readily available at the site.
- 9. Tools and equipment's necessary for calibration & servicing shall be brought by the service engineer of the firm.
