Sir,

ISP-Nashik issued above referred GeM contract to your firm i.e. **M/s. Nishant Power Solutions Private Limited, Thane** for Customized AMC/CMC for Pre-owned Products UPS for the period of one year with total cost of Rs. 8,08,949/- (Rs. Eight Lakh Eight Thousand Nine Hundred Forty-Nine only) inclusive of all taxes.

- 2. In this connection, it is regretted to inform that ISP had sent repeated reminders for providing services against the said-contract. Accordingly, ISP vide letter dated 28.07.2023, 25.03.2024 & 24.04.2024 issued a show cause notice to you and asked to submit the explanation why suitable disciplinary action may not be initiated against your firm. However, your response to show cause notice was not found satisfactory.
- 3. This is complete violation of terms and conditions of GeM contract and GeM bid due to repeated non-performance. In view of the above non-performance by the firm, your firm viz. **M/s.** Nishant Power Solutions Private Limited, Thane is put on debarment to participate in the GeM Bid/Tenders of India Security Press, Nashik for a period of one year i.e. upto 21st May, 2025 and security deposit of Rs.24,300/- submitted by you has been forfeited. Further, the said-GeM contract No. GEMC-511687741348152 dated 20.05.2023 has been terminated.
