With reference to captioned subject it is to mention that, IGM Kolkata has issued an open tender (No. 6000018060/CIVIL/45 Dated 12.07.2023) for construction of Road along with Surface Drain and one number underground Sump with Pump House at India Government Mint Residential colony, Kolkata. Your company participated in this tender and provided enlistment certificates issued by Uttarpara-Kotrung Municipality as part of the qualification process. However, upon verification, it was found that these certificates were not authentic, as confirmed by the respective municipality in details as below:

- 1. The letter dated 21.09.2023 was issued to Uttarpara-Kotrung Municipality for verification of certificates. In reply, Uttarpara-Kotrung Municipality vide letter dated 06.10.2023 has confirmed that the certificate M/ s. A-ONE COOL & ENGINEERS has submitted in the tender was not issued by Uttarpara-Kotrung Municipality and w.e.f. 16.08.2021 all Enlistment Certificate is being issued by the Municipality online & with a completely different format.
- 2. Consequently, M/s A-One Cool & Engineers, your firm, has been issued a show cause notice vide no. 54/P&S/PT-153(22-23)/1673 dated 09.02.2024 for submitting false information/documents during the tender process. M/s A-One Cool & Engineers has acknowledged this mistake and apologized.
