7) The vehicle should have necessary permits from the transport Dept./concerned Autho rity. SPMCIL will not be responsible for any challan, loss, damage and accident to the vehi cle or any other vehicle or injury to anybody.

8) The rate should be quoted inclusive of all expenses such as fuel (i.e. diesel/petrol), ta xes, maintenance, repair and servicing etc.

9) The vehicles on hire shall be available at all time including Saturdays, Sundays and p ublic holidays. One day compulsory rest in a week shall be allowed to driver as per conve nience of the vehicle user and driver.

10) The agency should have enough resources to repair their cars in minimum possibl e time. Whenever required, they should be in a position to substitute/replace or arrange e xtra vehicle(s) at very short notices. In case the vehicle(s) is found not to be in working co ndition, it shall be returned for immediate replacement. In case no replacement is provide d on time, this office would have a right to hire a vehicle from the market and the additio nal cost incurred due to hiring of another vehicle by this office will be borne by the contra ctor.

11) The air conditioners (A/C) of the vehicles deployed should have functional air cond itioning.

12) All statutory obligations, including payment/labour laws/regulations/motor vehicle Act etc must be complied by the contractor/agency.

13) All legal obligations which include insurance, pollution control, road tax & other co mpliances shall be complied by the contractor & SPMCIL will not be responsible in this re gard.

14) It is obligatory for the contractor that drivers are paid minimum wages according t o minimum wages fixed by the Govt. of Delhi/Central Government (as applicable) from ti me to time. A certificate to this effect has to be furnished every month along with monthl y bill.

15) Certificate regarding payment of EPF and ESI as applicable is to be furnished ever y month along with the bill by the agency.

16) The vehicles deployed should be registered with the concerned authority of Centr al/ State Govt. for the designated commercial use.

17) The agency/firm should provide single point of contact for all the communications related to contract and there should also be dedicated support team for contact round th e clock. The firm is also required to provide the escalation matrix for the contract.

18) The parking charges/toll tax and state tax, wherever applicable shall be reimburse

d at actuals on submission of receipts.

19) SPMCIL reserve the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at his quoted rates

20) The billing by Agency/Firm will be done on monthly basis and to be submitted in t he immediate next month to the concerned authority of SPMCIL Corporate office.

21) The vehicle should have the comprehensive insurance of vehicle, driver and pa ssengers etc. to cover the risk during the contract period. In case of any accident, all the claims arising out of it shall be met by the contractor and no claim whatsoever shall b e borne by SPMCIL.

22) In case of any dispute of any kind and in any respect whatsoever, the decision of S PMCIL shall be final and binding.

23) Vehicles which are hired on monthly basis for CMD/Directors/CVO will be parked a t their residence after duty hours, if required.

24) The contractor shall not engage any sub-contractor or transfer the contract to any other person.

25) SPMCIL reserves the right to short-close the contract between SPMCIL and the Co ntractor/agency with a one month notice period to contractor.

26) The tenderer, are advised to read the terms and conditions of the tender carefully and satisfy themselves about their fulfilling these conditions as also meeting the requirem ents of documents and other issues as mentioned in the Tender before submitting the ten der.

27) The successful bidder/agency shall disclose in writing all relevant facts as to owne rship of the agency and constitution of the business. If it is a proprietary concern, the nam e of the proprietor, if it is a firm, the names of all the partners and attested copy of partne rship deed; and if it is a company, the names of all the Directors, shall be disclosed. Furth er, if the said proprietor/any of the partners/any of the Directors has/have substantial inter est in any other agency, the said fact and the nature of the said interest shall also be disclosed. If the concerned agency has any associated concern/subsidiary/principal/holding co mpany/holding firm, the same shall be disclosed with full particulars.

28) The terms and conditions contained herein shall form part of and shall take as if th ey are included in the contract agreement to be entered in to between SPMCIL with the c ontractor.

29) The fuel (i.e. Diesel/Petrol) tank of the vehicle is to be kept full or which shall be s ufficient for at least 250 Kms per day. Time consumed/mileage required for intermediate refilling shall not be taken into account.

30) The contractor shall provide a log book with every vehicle in which it shall be ens ured that travel particulars such as departure time of vehicle from one point to another, ti me of arrival at destination, the Kms covered for the journey, etc. are entered correctly a nd signed by the officer traveling in the vehicle. The log book with the entries duly comple ted should be submitted to the Officer-in-charge along with the bill at the end of every mo nth. In case, the signatures mentioned above are not obtained, such journey will not be c ounted for the purpose of payment. If during any particular trip, it is noticed that the drive r has not met the time schedule given to him or that he has caused inconvenience to the passenger, penalty clauses will be invoked.

31) Submission of tender by the tenderer implies that he has read and accepts all the terms and conditions.

32) Cleaning and disinfecting the deployed vehicles to be ensured by Agency keeping in view the housekeeping & personal hygiene.

33) A certificate should be produced by the transporter from the competent authority to certify proper status/functioning of the "odometer" Kilometer reading. Meter should be completely sealed and should not be tampered. A thorough checking will be conducted fr om time to time and if found guilty, the SPMCIL shall have the right to cancel the contract.

34) There should be a first aid box, umbrella and air freshener spray etc. in every vehi cle.

35) Vehicle shall normally ply in Delhi NCR. However, vehicle may also be sent outsid e NCR and no extra payment shall be considered except Toll Tax and other applicable Tax es.

36) If any of above terms & conditions is not found fulfilled during the contract, the SP MCIL reserves the right to short-close the contract (by issuance of performance-cum-termi nation notice) without assigning any reasons thereof by providing a hearing to the contra ctor, if he so desires.
